3. THE "*" IDENTIFY EACH HIGH POINT CATEGORY
4. CLASSES WITH OUT THE "*" DO NOT COUNT TOWARDS HIGH POINT AWARDS

LOCAL PERPETUAL TROPHY CLASSES

CLASSES LISTED AS LOCAL ARE OPEN TO YOUTH EXHIBITOR 17 YEARS AND UNDER WHO RESIDE IN MENDOCINO COUNTY. THESE CLASSES HAVE AN ESTABLISHED PERPETUAL TROPHY. THE WINNER HAS HIS/ HER NAME AND YEAR WON ENGRAVED ON THE TROPHY.

IN ADDITION THE EXHIBITOR WILL RECEIVE RED ALDER WOODEN FRAME TO KEEP, ENGRAVED WITH THE EVENT AND TROPHY NAME.

THE RULES

1. AGE OF RIDER/HORSE WILL BE AS OF JANUARY 1 OF THIS YEAR
2. MUST BE 18 YEARS OF AGE TO EXHIBIT A STALLION
3. CLASSES WITH LESS THAN 3 EXHIBITORS MAY BE COMBINED / CANCELLED REFUNDS WILL BE CONSIDERED BY THE SHOW COMMITTEE, IF APPROVED REFUND CHECK WILL BE MAILED WITH IN 15 DAYS AFTER SHOW
4. ALL PRE ENTER MUST BE RECEIVED WITH PAYMENT OR OPEN CHECK, IF NOT, THEY WILL BE SUBJECT TO POST ENTRY FEE.
5. RETURNED CHECK FOR ANY REASON MUST BE REPLACED WITH A MONEY ORDER OR CASHIER'S CHECK PLUS A \$10.00 PENALTY FEE.
6. HARD HAT WITH HARNESS AND BOOTS ARE MANDATORY FOR ENGLISH CLASSES
7. MANDATORY WESTERN ATTIRE WILL INCLUDE BOOTS, LONG SLEEVES, HAT OR HELMET WITH HARNESS
8. POST ENTRIES WILL BE ACCEPTED UP TO 3 CLASSES PRIOR TO HIS/ HER CLASS. THE JUDGE IS NOT REQUIRED TO REVIEW PATTERN WITH EXHIBITORS
9. FANCY TACK, ATTIRE OR SILVER WILL NOT BE CONSIDERED IN THE JUDGING OF CLASSES. 4-H, FFA UNIFORMS ARE ACCEPTABLE.
10. LOCAL CLASSES FOR EXHIBITOR 17 YEARS AND UNDER RESIDING IN MENDOCINO COUNTY.
11. MANAGEMENT HAS THE RIGHT TO EXCUSE UNRULY ANIMALS
12. UNSPORTSMANLIKE LIKE BEHAVIOR WILL NOT BE TOLERATED! YOU WILL BE EXCUSED FROM THE CLASS/GROUND AND FORFEIT ALL ENTRY FEES
13. ANY PROBLEMS / QUESTIONS SHOULD BE BROUGHT TO THE SHOWS MANAGEMENT IN THE EVENT OF A DISPUTE, MANAGEMENT/JUDGE DECISION WILL BE FINAL.
14. HIGH POINT TIES WILL BE BROKEN BY CONTESTANT WITH THE HIGHEST SHOWMANSHIP SCORES.
15. A HORSE MAY NOT BE RIDDEN TWICE PER EVENT (EXCEPT LEAD LINE)
16. IF THE HORSE CANNOT BE CONTROLLED IN THE ARENA IT WILL BE EXCUSED.

I HAVE READ AND AGREE TO THE ABOVE RULES AND I ACKNOWLEDGE THAT HORSEBACK RIDING IS A SPORT WHICH CARRIES INHERENT RISK OF INJURY AND DAMAGE TO MYSELF, MY HORSE AND PROPERTY. I HEREBY ENTER THE HORSE SHOW PREVIOUSLY MENTIONED AT MY OWN RISK AND SUBJECT TO ALL RULES AND REGULATION OF THE SHOW. I FURTHER AGREE THAT IF ANY DAMAGE BE OCCASION BY, OR LOSS, OR DAMAGE OCCUR FROM ANY CAUSE TO THE HORSE, I WILL MAKE NO CLAIMS THEREOF. I FURTHER AGREE TO INDEMNIFY WILLITS FRONTIER DAYS, INC. AGAINST ANY LEGAL PROCEEDING FOR PERSONAL INJURIES OR PROPERTY DAMAGE ARISING OUT OF MY PARTICIPATION IN THE EVENT. I AGREE TO THE CONDITIONS SET FORTH. I ACKNOWLEDGE THAT I HAVE READ THIS RELEASE OF LIABILITY AND KNOW AND UNDERSTAND AND ITS CONTENTS.
